WORLD COUNCIL OF INDIGENOUS GAMES (WIG) is a non-governmental and non-profit organization registered according to Indian law at the Tamilnadu. The WIG General Assembly is the supreme governing body of INDIGENOUS GAMES and elects the WIG Board of Directors every five years.

ORIGINS AND STATUS

- The purpose of WIG is to promote & develop Indigenous Games through research also educate to improve health through physical activities.
- WIG will not collect money from members and its organizations. Also, Board of directors, regional bodies and Active members shall not receive any salary from WIG. WIG programs, seminars, etc may receive a donation for WIG development. And no person will be receiving financial rewards which violate the WIG statutes and bylaws.


